

**Frequently asked questions about the
'Attachment Theory and its Clinical Applications course 2024'**

1. Will I receive a certificate on completion of the seminar series of the 'Attachment Theory and its Clinical Applications course 2024'?

If you have signed up for the full course- and attended at least 7 of the 9 days, you are eligible to qualify for the certificate. In case you cannot attend the live sessions, we will make the recordings available to you for a limited period of 2 weeks. However the facilitated group discussions at the end of the two lectures on the course dates will not be included in the recordings.

2. Will I receive a certificate if I opt to attend a single seminar?

No. The minimum criteria for obtaining the certificate is attending at least 7 of the 9 day-long sessions.

3. Can I change my seminar dates?

No, the seminar dates and timings are fixed. However, in the event that you cannot attend any of the lectures you have signed up for, a link of the recording will be shared with you. You will have access to the recordings of the lectures for two weeks. The facilitated group discussions will not be part of the recordings and will only happen for members who are able to attend live.

4. How do I know my seat has been confirmed?

Please follow the instructions that have been laid out and shared with you. After completing your registration on eventbrite, you are expected to email the screenshot to ianindia20@gmail.com
You will receive a confirmation within 7 working days.

5. I have opted for the full series, is there a minimum attendance criteria?

Yes, 77% or a minimum of 7 out of the 9 days is the qualifying criteria to receive the certificate.

6. Will there be a single link for all the seminars or will a separate link be sent before every seminar?

Separate links will be sent before each seminar. Please check your spam folder. In case you face any difficulties locating the links please email ianindia20@gmail.com

7. Is this course different from the Post Graduate Certificate Course previously offered by IAN India in 2021?

Yes. The premise of attachment theory remains central throughout the course. However, this program is formulated to introduce, as well as build on the previous course by highlighting its clinical applications for mental health professionals.

8. On successful completion of the series of the 'Attachment Theory and its Clinical Applications course 2024', will I be eligible for membership with IAN India?

Yes, successful completion of the series (or attending a minimum of 3 of the individual seminar days) would enable you to become a member of IAN India. You will be required to share basic details around your work, training and supervision with the IAN India team after completion of the training at ianindia20@gmail.com.

9. What is the minimum eligibility criteria for IAN India's membership?

A minimum of 3 of individual seminar days qualify you for membership with IAN India. Please email us with the required information mentioned in the membership page of the IAN India website. (**NOTE** : for those attending this seminar series 2024, you do not have to send in reflective essays on the same)

Please write to ianindia20@gmail.com with a screenshot of the same.

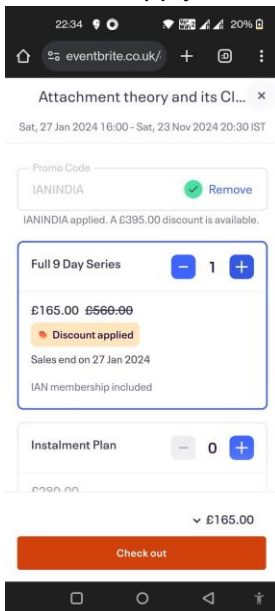
11. Where do I use the coupon Code?

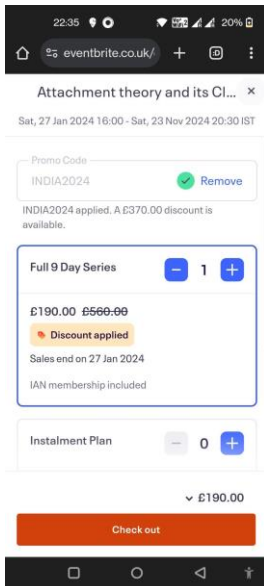
Once you click the link for the whole course you will be directed to the eventbrite page



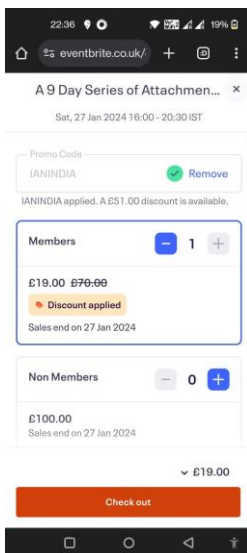
If you are an **IAN India member** kindly use the code “IANINDIA” under Promo Code, and click apply. The discount will reflect once you apply code.

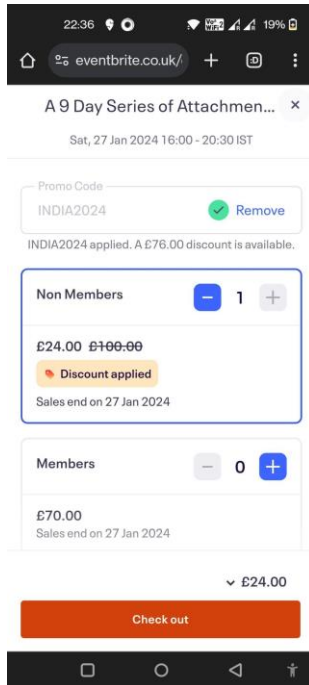


If you are from within India, but **not an IAN India member**, please use the code “INDIA2024” under Promo Code. The discount will reflect once you click apply

The code for members of IAN India is **IANINDIA**.

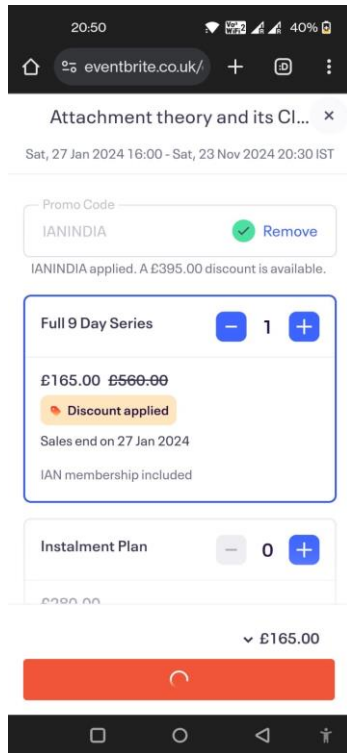
The code for non members is **INDIA2024**.

13. Do I need an international card to make the payment?

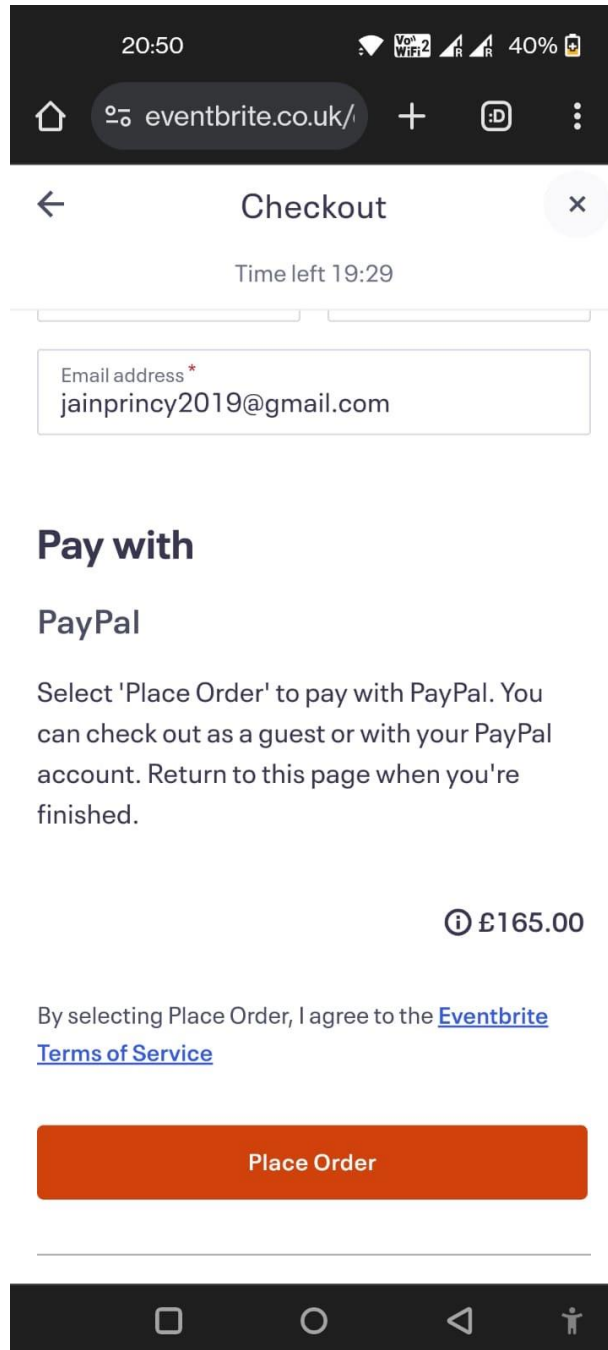
When you register, you will see an option to pay with "**PayPal**"- please click **place order**. You will be directed to a page where you have the option to pay with PayPal if you already have an account. If you do not have an account- it is a fairly simple process. You could create a PayPal account. Alternatively, If you do not have a PayPal account, then you could log in as a guest, and use any major international card to make a payment.

To make this process simpler for you, we are adding a few screenshots of the payment process.

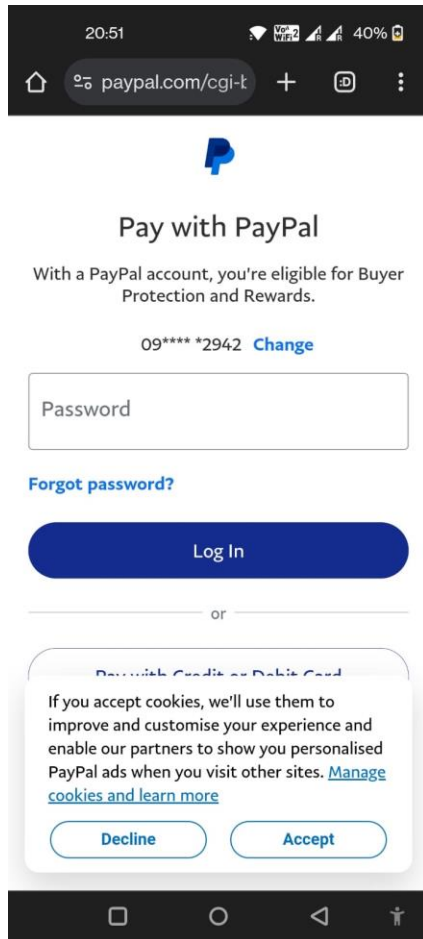
1. Select either full series or single seminar and mention the code. Please mention the correct code.



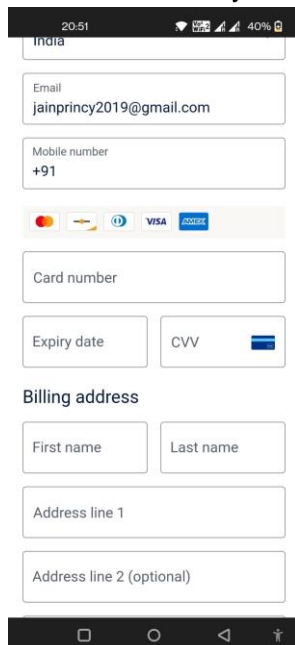
2. Place your order

14. I cannot attend the series, do I get a refund or can I offer it to someone else?

No, the payments are **non-refundable** and **non-transferrable**.

15. Can I make payments in installments?

No. Payments are made in one go and not in installments.

16. What happens if I use the code for members when I am not in fact an IAN India member?

Please ensure to use the membership code only if you are an IAN India member. The IAN India team will cross check our list of IAN India members. In case you have paid member fees, and are not a member, someone from our team will reach out to you via your registered email, and you will be requested to pay the balance directly to the IAN UK bank account and send us the screenshots for the same. Once you email the same with us, your place will be reserved for the course. Please note that any amount paid is **non-refundable, and non-transferable**. So to save your spot you will be required to pay the mentioned amounts as per your membership status.

17. I have missed the single seminar that I have opted for. What can I do about it?

The recording of the lectures that you have signed up for will be shared with you for a limited period of 2 weeks. You could go through them at your ease and convenience.

18. Will the seminars be recorded? Will I be able to access the recording?

Yes. The link to the recording will be shared with you after the lectures. They will be accessible to you for a **period of two weeks**.

19. When can I hear back from IAN India about the scholarship results?

20. What is the last date to register?

You can apply for the single seminar capsule upto 24 hours before the lecture starts.

21. When can I register for a single seminar capsule?
